TERMS AND CONDITIONS

AQUATICS/CENTRE BOOKINGS

- All Aquatic Bookings require a minimum of 14 days' notice on application for staffing purposes
- Age and ability restrictions apply for all aquatic equipment
- All bookings are to adhere to the **"Watch around water"** policy: **all children under 6 years of age must be in arms reach of an adult/parent at all times.**
- Groups will not be admitted where the number of parent/guardians to children ratio exceeds 1:4. This ratio applies for under six (6) years of age
- Groups will not be admitted where the number of parent/guardians to children ratio exceeds 1:10 This ratio applies for under eleven (11) years of age
- All users of Aquatic Equipment during a booking/public use are required to undergo a swim test in the area of the pool the equipment is located in. Any users that cannot demonstrate required swimming level will not be permitted on the equipment for safety reasons
- No booking is considered confirmed without a deposit made and written confirmation from the Senior Officer Facility & Events
- No food or drink to be taken onto courts
- All minors attending bookings are to remain in the booked area under full supervision at all times
- Bookings cancellations and modifications must be submitted in writing
- Deposit of 25% is required to secure all casual bookings
- All payments to be made in full prior to commencement of booking, no shows and failure to cancel will incur full booking costs.
- Damage to building or equipment will be charged to the hirer at the discretion of the Centre
- City of Kalgoorlie-Boulder and Goldfields Oasis reserve the right to cancel any bookings as required by any unforeseen circumstances or major events

SWIM TEST ACKNOWLEDGEMENT

For use of Aquatics: slides, inflatables and pool lanes

- AGE AND ABILITY RESTRICTIONS APPLY FOR ALL AQUATIC EQUIPMENT.
- Inflatables as set up according to required depths in certain areas of the pool.
- I will adhere to the **"Watch Around Water"** policy: all children under 6 years of age must be in arms reach of an adult/parent at all times.
- All users of Aquatic Equipment during a booking/public use are required to undergo a swim test in the area of the pool the equipment is located in before being allowed to use inflatable.
- All users are to follow directions by designated lifeguards regarding use, safety and time.
- Any users that cannot demonstrate required swimming level will not be permitted on the equipment for safety reasons.
- I acknowledge that I have read the above and understand some attendees may not be permitted on the equipment I have hired if they cannot complete the swim test.
